Lenora has over three decades of leadership experience in nonprofit management, primarily at

Southwest Solutions, where she was Executive Director before accepting her new appointment as President and CEO of the Judson Center. Lenora also chaired Southwest Solutions' Executive Leadership Team as well as serving on several non-profit governing boards. In addition, Lenora is President of the Detroit Chapter of Financial Executives International (FEI). Gabriella, who works for Wayne County, founded the nonprofit organization Livernois SOUP, and is also a member of Challenge Detroit, a leadership and professional development program that invites future leaders to live, work, play, give, and lead in the Detroit area for one year. The moderator of the event will be Fr. Phil Cooke, S.J., Director of the Center for Social Entrepreneurship.
