MBA Program Ranked 16th In The Nation

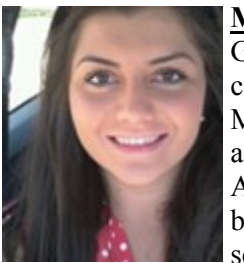
Nancy Hazely is the founder and Chief Executive Officer of Dearborn-based Tax Trilogy, LLC, one of the nation's foremost sales and use tax compliance service providers. Founded in 2007, the firm operates in Michigan and Florida, servicing several Fortune 500 companies. She majored in Accounting and graduated with a Bachelor of Science degree in 1978, working in various capacities including finance and taxes over the past 25 years. She currently is serving on the Board of Advisors for the College of Business Administration, as well as on the board at Cornerstone Schools in Detroit. Hazely has represented the University at many events, in her commitment to assisting the community and youth in our area.



Edward T. Sporck is a veteran of 34 years of working in the automotive industry with Chrysler Corporation in its various forms. Sporck earned a degree in Electrical Engineering, joining Chrysler on a full-time basis after graduating. After completing his MBA from the College of Business Administration in 1978, he worked as a machining supervisor before moving up in the corporation. In 1999, he was appointed as Director of Logistics, using his leadership to expand all global transportation and customs for the Chrysler Group. The alum has always kept the University in a special place in his mind and heart, referring to himself as a "Jesuit-a-holic," having been educated at Jesuit institutions his entire life. He attributes his practical approach to life and his personal philosophies on leadership and education to his Jesuit experiences.



Emily Doerr is on a lifelong quest in pursuit of quality and service to others. Currently, she works for the City of Flint in the Community and Economic Development Division as program manager, overseeing all housing initiatives. She works to support the Imagine Flint master plan and the needs of the community development corporations, serving low to moderate-income residents. While pursuing her MBA at the University of Detroit Mercy, she founded Hostel Detroit in April 2011, with the help of volunteers.
