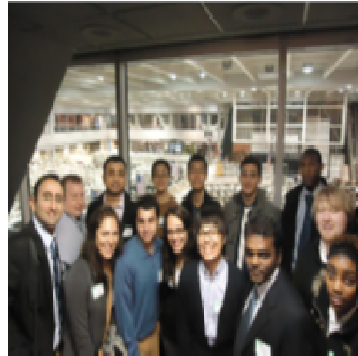

Welcome, Freshmen!

The College of Business Administration is pleased to welcome its newest class of first-year students! Like our returning students, the incoming class is highly diverse. Roughly 58% are male and 42% are female. They come from a number of Midwestern States, including Michigan, Ohio, Wisconsin, and Illinois, as well as from Eastern Europe, Western Europe, and Asia. They have fluency in various languages, including Spanish, Italian, Japanese, Chinese, and even American Sign Language. Roughly half are athletes who plan to play sports at UDM, including basketball, softball, lacrosse, track and field, golf, and soccer. Approximately 70% will live in dormitories on campus, and 30% plan to commute. About 40% plan to be employed on a part-time basis while they pursue their academic studies. And about one-third will be in the 5-year BS/MBA program. Aside from business, their other interests include digital media, journalism, museums and art, kinesiology, psychology, medicine, and law. One thing they all have in common is their academic excellence. Their average high school grade-point average was 3.38, and 24% of the incoming students were among the top ten percent of their respective high school classes. Their average ACT score was 24.25, far higher than the average in Michigan (20.1) and the United States as a whole (21.1). Indeed, 25 percent of the incoming freshmen to the College of Business Administration were among the top ten percent of students nationwide, based on their ACT scores. And they bring a variety of Advanced Placement credits with them to begin their college careers, including credits in Calculus, Statistics, Government, English, Literature, Composition, American and European History, Biology, Chemistry, and Art. We are extremely confident of their success as students in the College of Business Administration, and we wish them all the best!

CBA RETIREMENTS



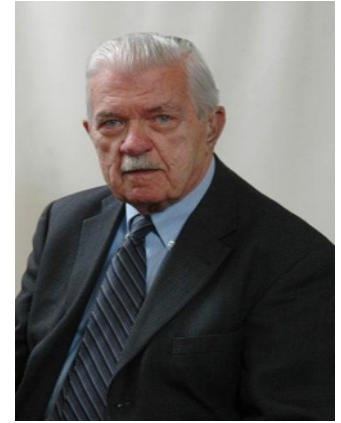
Fr. Oswald A. J. Mascarenhas, S.J. earned his MBA and Ph.D. degrees from the Wharton School of Business at the University of Pennsylvania. A priest, teacher, and scholar, Fr. Mascarenhas taught graduate and undergraduate courses in Marketing and Business Turnaround Management (BTM); indeed, he was instrumental in launching the BTM program. An avid scholar, he is the author of numerous books, monographs, and journal articles addressing the ethics of domestic and global marketing strategies, internet marketing and consumer/computer privacy. One of his most recent publications is “Government Bailouts, Financial Sector Turnaround and Wicked Problems”, coauthored with Dr. Ram Kesavan, Anand Kesavan, and Trevor Crick. After nearly three decades at the University, Fr. Mascarenhas was asked by the Society of Jesus to undertake the development of graduate programs at St. Aloysius College in India.



Ms. Mary Hassett retired as Assistant to the Dean in the College of Business Administration at the University of Detroit Mercy in June of 2012. Joining the College in 1987, Mary assisted a series of seven Deans through momentous and even historic events, including the consolidation of Mercy College and the consolidation of Mercy College and the University of Detroit, as well as the renovation of the Commerce and Finance Building. UDM UPCOMING EVENTS

For the 12th consecutive year, University of Detroit Mercy is listed among the best regional universities in the Midwest, in the *U.S. News & World Report* ranking of "Best Colleges." In addition to the University's ranking rising from #23 to #20 in the magazine's annual list of regional universities, it was also one of the highest in the state, ahead of UM-Dearborn, Grand Valley State, Lawrence Tech, Ferris State, and Eastern Michigan. "University of Detroit Mercy's students, faculty and staff are the primary reasons why UDM's ranking is the highest ever," said University of Detroit Mercy President Antoine M. Garibaldi, Ph.D. "This honor is a tribute to the quality of teaching, scholarship and mentoring that they provide every day in our undergraduate, graduate and professional programs as our students are prepared for future leadership roles in their professions and communities." In the past five years, over 95% of the University's graduates had positions in their fields or had entered graduate school within six months of graduation. Highlights of the latest college rankings will be published in the *U.S. News & World Report's* Best Colleges" 2013 edition guidebook, which went on sale on Sept. 18 at newsstands and at usnews.com. The *U.S. News* college rankings group more than 1,400 accredited four-year schools based on categories created by the Carnegie Foundation for the Advancement of Teaching and compares them based on a set of 15 widely accepted indicators of excellence.
