Dr. Randy Elder, CBA, Accounting, 1979, is Senior Associate Dean of the Whitman School of Management, Syracuse University. He is the "right hand man for the dean", and is also Professor of Accounting. Randy's mother, father, and three brothers also graduated from U of D - all in business, except one brother in engineering. Randy's father taught at the downtown Dowling Hall Evening College of Business for decades.

Dr. Ryuzo Sato, CBA, MBA, 1959, recently visited the campus and the College of Business. He is recently retired as Starr Professor of Economics and Director of the Center for Japan-U.S. Business and Economic Studies at The Stern School of Business at New York University. Dr. Sato is one of the preeminent economists in the world, has authored many books, and has had a conference dedicated to his life's work.
